

U.S. Immigration Support: Finding an Attorney, Community Resources, National Organizations, and Government Links

How to Find a Licensed Immigration Attorney:

International students, faculty, researchers, and staff may use this guide as a resource to find an immigration lawyer to assist with personal immigration questions and concerns, as well as locate community-based immigration resources available at a reduced cost.

American Immigration Lawyers Association (AILA)

The American Immigration Lawyers Association (AILA) is a nonprofit association of attorneys in the United States that specialize in immigration law. The AILA website has a tool for finding an immigration lawyer to assist with immigration questions and concerns based on personal need and geographic location. All attorneys listed in the “Find an Immigration Lawyer” database are licensed attorneys, in good standing in at least one state, and have been an AILA member for a minimum of two years.

To find an immigration lawyer on the [AILA website](#) that specializes in your immigration need:

1. Select the type of immigration lawyer from the drop-down option, e.g. Asylum, Family, Business and Employment, Deferred action/DACA, Waivers, etc.
2. Enter the preferred language, your geographic information and click “search”
3. A list of attorneys specializing in your immigration need will appear.

List of Pro Bono Legal Services Providers (EOIR)

The Executive Office for Immigration Review (EOIR), Office of Policy, Office of Legal Access Programs (OLAP) administers the List of Pro Bono Legal Service Providers or the “List”. The List is provided to individuals in immigration proceedings and contains information on non-profit organizations and attorneys who have committed to providing at least 50 hours per year of pro bono legal services before the immigration court location where they appear on

the List. The List also contains information on pro bono referral services that refer individuals in immigration court proceedings to pro bono counsel. Information related to the List can be found here:

Government Immigration Agencies

U.S. Citizenship & Immigration Services (USCIS)

USCIS is a sub agency of the U.S. Department of Homeland Security (DHS). USCIS is the federal agency that grants immigration benefits from within the United States. USCIS is responsible for adjudicating most temporary and all permanent immigration "green card" status and establishes policies regarding immigration services. USCIS publishes immigration program updates and procedures at: <https://www.uscis.gov/> .

U.S. Customs & Border Protection (CBP)

CBP is the federal agency charged with enforcing U.S. trade, customs, and immigration regulations at U.S. international borders and ports of entry, such as international airports and land crossings. CBP Officers are tasked with inspecting all travelers at U.S. ports of entry, *determining admissibility in legal immigration status*, and issuing I-94 arrival-departure records which is a legal status document. U.S. Department of State (DOS)

DOS is the federal agency responsible for U.S. foreign policy including oversight of U.S. Embassies and Consulates abroad. DOS publishes city-specific information for visa applications and appointment wait times at: <https://travel.state.gov/content/travel/en/us-visas.html>.

Student and Exchange Visitor Program (SEVP)

SEVP is a jointly operated program of the Departments of Homeland Security and State. The F-1 international student program is managed by Immigration and Customs Enforcement (ICE), a sub agency of DHS. The J-1 exchange visitor program is managed by the Bureau of Educational & Cultural Affairs at DOS. Both agencies use the [Student and Exchange Visitor Information System \(SEVIS\)](#) to track and monitor compliance of SEVP certified schools as well as F students and J visitors. The Executive Office for Immigration Review (EOIR) is a subagency of the U.S. Department of Justice and is charged with adjudicating immigration cases by interpreting and administering U.S. immigration laws.
